

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at the bid opening.

Bid documents are available from the date of this advertisement until the opening of bids at the City General Service Office, 2<sup>nd</sup> Floor, Main Building, Rizal St. corner Hilario St. Ligtasan, Tarlac City.

Interested bidders should submit their duly accomplished bid proposals to the BAC Secretariat not later than 2:00 P.M. on the date of opening of bids. Bid form/s shall be paid directly to the City Treasurer's Office in the amount of Php 10,000.00 for the Item No. 1 and Php 5,000.00 for the Item No. 2-7. Payment of bid form/s is non-refundable.

All other matters not specified herein shall be governed by pertinent provisions of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".
