Bids received in excess of the ABC shall be automatically rejected at the bid opening.

Bid documents are available from the date of this advertisement until the opening of bids at the City General Service Office, 2nd Floor, Main Building, Rizal St. corner Hilario St. Ligtasan, Tarlac City.

Opening of Bids shall commence at exactly 2:00 P.M. on April 5, 2018 at the Bid and Awards Committee Conference Room. Pre-bid Conference is set on March 23, 2018 at 2:00 P.M. at the Bids and Awards Committee, Conference Room, City Legislative Building, 2nd floor, Rizal St. corner Hilario St. Ligtasan, Tarlac City.

Interested bidders should submit their duly accomplished bid proposals to the BAC Secretariat not later than 2:00 P.M. on the date of opening of bids. Bid form/s shall be paid directly to the City Treasurer's Office in the amount of P 5,000.00 for the Item No. 1-4, P 1,000.00 for the Item No. 5-7. Payment of bid form/s is refundable.

All other matters not specified herein shall be governed by pertinent provisions of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".
